4. Container Stuffing / Loading Supervision

In this kind of inspection, our inspectors are in attendance while the consignment is being stuffed into containers or loaded onto the vessel or truck.

Conformity Assessment

As per Islamic Republic of Iran law and regulations, a number of goods are subject to compulsory standards and technical regulations for imports. Importers are required to have the goods assessed and certified as conforming to the acceptable standards in accordance with the approved methods of Assessing the Conformity of Imported Goods under Index R/131/35 , issued by Institute of Standards and Industrial Research of Iran (INSO).



Bekhrad International Inspection Services (BIS) has adapted its structure and procedures for fulfilling the above requirement with utmost accuracy and smoothness to ensure benefit to Manufactures, Suppliers, Importers, Consumers and Government Regulators.

BIS services in this field include:

Inspection of escalators and moving walkways



Nowadays, the use of escalators and moving walkway in public centers such as subway and train stations, airports, pedestrian bridges, hospitals and commercial centers is increasing. The purpose of installing such equipment is to facilitate the movement of people or people handling cargo, although it is not always safe to use them. With a brief look at the situation of escalators and moving walkways in the country and around the world, reported accidents and numerous financial and human losses as well as their analyze, the importance of reviewing and checking after the installation operation and before the operation of the unit, maintenance services and periodic inspections have received more attention. Incidents occur in different parts of the world such risks can be prevented by timely inspection and safety of devices and bring confidence and comfort to users.

Inspection operations:

Inspection of escalators and moving walkways according to EN 115-1 includes reviewing all safety requirements of users, service workers and inspectors and persons present in the installation area of the device, measuring and reviewing dimensions, safety distances specified in aforesaid standard, clearance spaces required before entering, the time of placing on the device and after leaving the passenger, safety equipment tests and the performance of the device before operation and reviewing the documents.

Inspection license:

Bekhrad International Inspection Services Company is accredited by the National Standards Organization of Iran for the inspection of escalators and moving walkways and by using experienced inspectors, has the ability to inspect all types of escalators and moving walkways in different parts of the country and even beyond the borders with precision and skill, and if the device complies with the standard EN 115-1, issue a safety certificate.

Inspection of escalators and moving walkways

Inspection process:

- 1- Refer to the inspection company to register the inspection request and provide the following items:
 - Request for inspection
 - Preliminary documents of the case
 - Pay the inspection fee
- 2- Inspection planning by the inspection company
- 3- Announcing the inspection time to the inspection applicant in order to provide the inspection conditions and the presence of the representative of the company supplying the device during the inspection.
- 4- Sending the inspector by the inspection company to the place of installation of the device at the announced time
- 5- Carrying out inspections and tests before operation in the presence of the representative of the device supplier company
- 6- Announcing discrepancy report of possible non-compliance with the standard EN 115-1 by the inspector
- 7- Elimination of possible discrepancies announced during the inspection report
- 8- Continuing the inspection process such as requesting re-inspection, planning, coordination and dispatch of the inspector
- 9- Completion of the documents of the job file after the approval of the device by the inspector
- 10- Issuance of inspection certificate



Energy Consumption Criteria Inspection

Due to dramatic increase in energy costs in the world on the one hand and the limitation of fossil fuels and the high annual growth of energy consumption in Iran and the elimination of related subsidies in most industries on the other hand, today energy consumption management and energy efficiency increase has become inevitable. For this reason, the monitoring and energy consumption management in each industry needs its own appropriate criteria and indexes. Therefore, according to the Law on “Modification of the Energy Consumption Model”, the Iranian National Standards Organization has developed and enforced relevant energy consumption standards. So that all consumers, manufacturers, and importers of energy-based equipment set up their systems based on criteria and technical specifications in accordance with developed standards.

Certification Issuance of Energy Consumption Criteria:

In accordance with the observation of energy consumption criteria standards, the Iranian National Standards Organization shall annually inspect and determine the energy consumption criteria of the industries covered (list of industries covered) to the accredited inspection companies. Accordingly, Bekhrad Inspection Company, as one of the companies licensed by the National Accreditation center of Iran, is required to monitor and ensure compliance with the requirements of energy consumption criteria in coordination with the manufacturer (industry covered) to be inspected and reported annually to the Iranian National Standards Organization to issue the certificate of standardization for the manufacturer if the inspection report complies with the standard requirements.



Energy Consumption Criteria Inspection

Certification Process of Energy Consumption Criteria:

- 1. Receiving initial documentations from manufacturer**
- 2. Review of documents and inspection contract**
- 3. Initial visit from the production unit includes:**
 - Receiving copy of the electricity, gas and liquid fuel bills for the year under review
 - Inserting information about production processes in the factory
 - Recording the number and types of product lines
 - Recording the annually production per month
 - Determination of the main and secondary sources of energy consumption
 - Visiting active product lines
 - Checking the installation points of the meters
 - Checking the calibration of the meters
 - Determination of specific and effective cases in the amount of energy consumption
- 4. Secondary visit (if necessary)**
- 5. Completion of the required documents and inquiries from the relevant authorities**
- 6. Summarizing and analyzing information**
- 7. Receiving approval and commitment from the industrial unit based on the accuracy and verification of the documents**
- 8. Compilation of report for submission to The Iranian National Standards Organization**

Vehicle Type Approval Inspection

More than half a century has passed since the production of vehicle in the country, and its production and imports are increasing every day. This dramatic expansion has led the Iranian National Standards Organization to provide and enforce the required standards in two sections of vehicle components and assemblies in order to monitor the production and importing process. In the first section, monitoring vehicle components in the form of components standards and in the second section, monitoring vehicle assemblies in the form of type-approval standards is required. Therefore, all vehicle manufacturers and importers should observe these requirements to produce products with appropriate safety, functional and environmental features.



A-Domestic Production Vehicles

1- Issuance of Type -Approval Certificate for Domestic Production Vehicles

In accordance with the observation of vehicle type-approval standards, and in order to receive production and plate license, all domestic manufacturers are required to obtain a type-approval certificate from the Iranian National Standards Organization. Accordingly, **Bekhrad Inspection Company**, as one of the companies accredited by the National Accreditation Center of Iran, at the request of the Manufacturer and to check and ensure compliance of the type-approval standards, inspects the Manufacturer and its products. After providing the inspection report to the Iranian National Standards Organization, The Organization shall issue a type-approval certificate for the product, if the inspection report complies with the standard requirements.

2- Issuance of **Product** Conformity Certificate for Vehicle Production Units / Manufacturers

Based on the Iranian National Standards Organization requirement, after issuance of the vehicle type-approval certificate, all domestic vehicle manufacturers, have to assign the monitoring of conformity of production system to one of the accredited inspection companies. In this way, inspection companies are required, on the one hand, to inspect the processes and quality assurance of the manufacturers during the evaluation period in order to ensure conformity of the production with the approved type ,and on the other hand , to ensure continuity of controls and the effectiveness of quality management systems in coordination with the manufacture or at random and send the relevant inspection report to the Iranian National Standards Organization seasonally. If the inspection report complies with the standard requirements, at the end of the evaluation period, The Organization shall issue certificate of production conformity and manufacturer's certificate of product type-approval be extended.

Vehicle Type Approval Inspection

B-Imported Vehicles to the Country

1- Issuance of Imported Vehicles Type-Approval Confirmation Certificate

In order to comply with the vehicle type-approval standards and because of the need to obtain import license, all vehicle importers are required to obtain a type-approval confirmation certificate for the imported vehicle from the Iranian National Standards Organization. Accordingly, Bekhrad Inspection Company, as one of the companies accredited by the National Accreditation Center of Iran, at the request of importers and in order to check and ensure conformity of the type-approval standards, verify type-approval documents (general or separate) and perform physical inspection of the type of vehicle. After providing and sending inspection report to the Iranian National Standards Organization, The Organization shall issue type-approval confirmation certificate for importing products, if the inspection report complies with the standard requirements.



2-Issuance of Physical Inspection Certificate of Imported Vehicles:

Based on the Iranian National Standards Organization requirement, after issuing the certificate of type-approval of imported vehicles and the entry of vehicles into customs for clearance and numbering, all vehicle importers should send their request to Provincial General Bureau of Standard. That organization, in order to check the type-approval of imported vehicles, which have type-approval confirmation certificate, assign the physical inspection to one of the accredited inspection companies. According to this, inspection companies are required to perform a full physical and 100 per cent inspection of the imported vehicles and send the inspection report to General Bureau of Standard for issuing clearance permit, if the inspection report complies with the type-approval confirmation certificate.

Vehicle Type Approval Inspection



Bekhrad Inspection Company's Licenses in the field of Vehicle Inspection:

The scope of services of Bekhrad Inspection Company in the field of Technical Inspection and Vehicle Type-Approval is based on the certification issued by the National Accreditation Center of Iran and in accordance with "Type approval of motor vehicle and their trailers, and of systems, components and separates technical units intended for such vehicle" standard No. 6924 as follows:

- 1- Types of passenger Vehicle with a capacity of up to 9 persons , subject to group M1
- 2- Types of minibuses and middle-bus with a capacity more than 9 tons up to 5 tons , subject to group M2
- 3- Types of bus and middle-buses with a capacity of more 9 tons up to 5 tons, subject to group M3
- 4- Types of pickups and vans with a capacity up to 3.5 tons , subject to group N1
- 5- Types of trucks with a capacity of 3.5 to 12 tons , subject to group N2
- 6- Types of caravans and towing with a capacity exceeding 12 tons subject to group N3
- 7- Types of caravans and trailers with a capacity of up to 750 kg subject to group O1
- 8- Types of caravans and trailers with a capacity of 750 kg to 3.5 tons subject to group O2
- 9- Types of trailers and semi-trailers with a capacity of 3.5 to 10 tons , subject to group O3
- 10- Types of trailers and semi-trailers with a capacity exceeding 10 tons subject to group O4



Motorcycle Type Approval Inspection

More than half a century has passed and the motorcycle production scope is expanding every day in the country. This expansion has led the Iranian National Standards Organization to Provide and enforce the required standards in two sections of motorcycle components and assemblies in order to monitor the production and import process. In the first section, monitoring of motorcycle components, in the form of components standards and in the second section, monitoring of motorcycle assemblies, in the form of type-approval standards is required, until all motorcycle manufacturers observe these requirements to produce products with appropriate safety, functional and environmental features.

A- Issuing Type-Approval Certificate for Domestic Production Motorcycles

In accordance with the observation of motorcycle type-approval standards, and in order to receive production and numbering license, all manufacturers are required to receive a type-approval certificate from the Iranian National Standard Organization. Accordingly, Bekhrad Inspection Company, which is one of the companies accredited by the National Accreditation Center of Iran, at the request of the manufacturer, in order to check and ensure conformity of the type-approval standards, inspects the manufacture and its products. After providing the inspection report to the Iranian National Standards Organization, the organization shall issue a type-approval certificate for the product, if the inspection report complies with the standard requirements.

B- Issuing Product Certificate of Conformity for motorcycle manufacturers:

After the issuance of the motorcycle type-approval certificate, the Iranian National Standards Organization, every year to monitor the production matching system, assigns inspection of the manufacturer to the accredited inspection companies. Therefore, inspection companies are required to inspect the process and quality assurance of manufacturers during the evaluation period in order to ensure conformity of the production with the approved type, on the one hand, and to ensure continuity of controls and the effectiveness of quality management systems, on the other hand, in coordination with the manufacture or, at random. Complete manufacturers' quality management processes and systems during the evaluation period and send the relevant inspection report to the Iranian National Standards Organization seasonally so that if the inspection report complies with the standard requirements, the organization, to issue certificate of conformity of production at the end of the evaluation period, and manufacturer certification of product type-approval to be extended.

Motorcycle Type Approval Inspection

Bekhrad Inspection Company's licenses in the field of Motorcycle Inspection:

The scope of services of Bekhrad Inspection Company in the field of Motorcycle Type-Approval is based on the certification issued by the National Accreditation Center of Iran and in accordance with "Type-Approval of two or three-wheel motor vehicles" standard No. 7558 as follows:

- 1- Types of moped and electric motorcycle included in group L1
- 2- Types of three-wheel moped and electric motor tricycle included in group L2

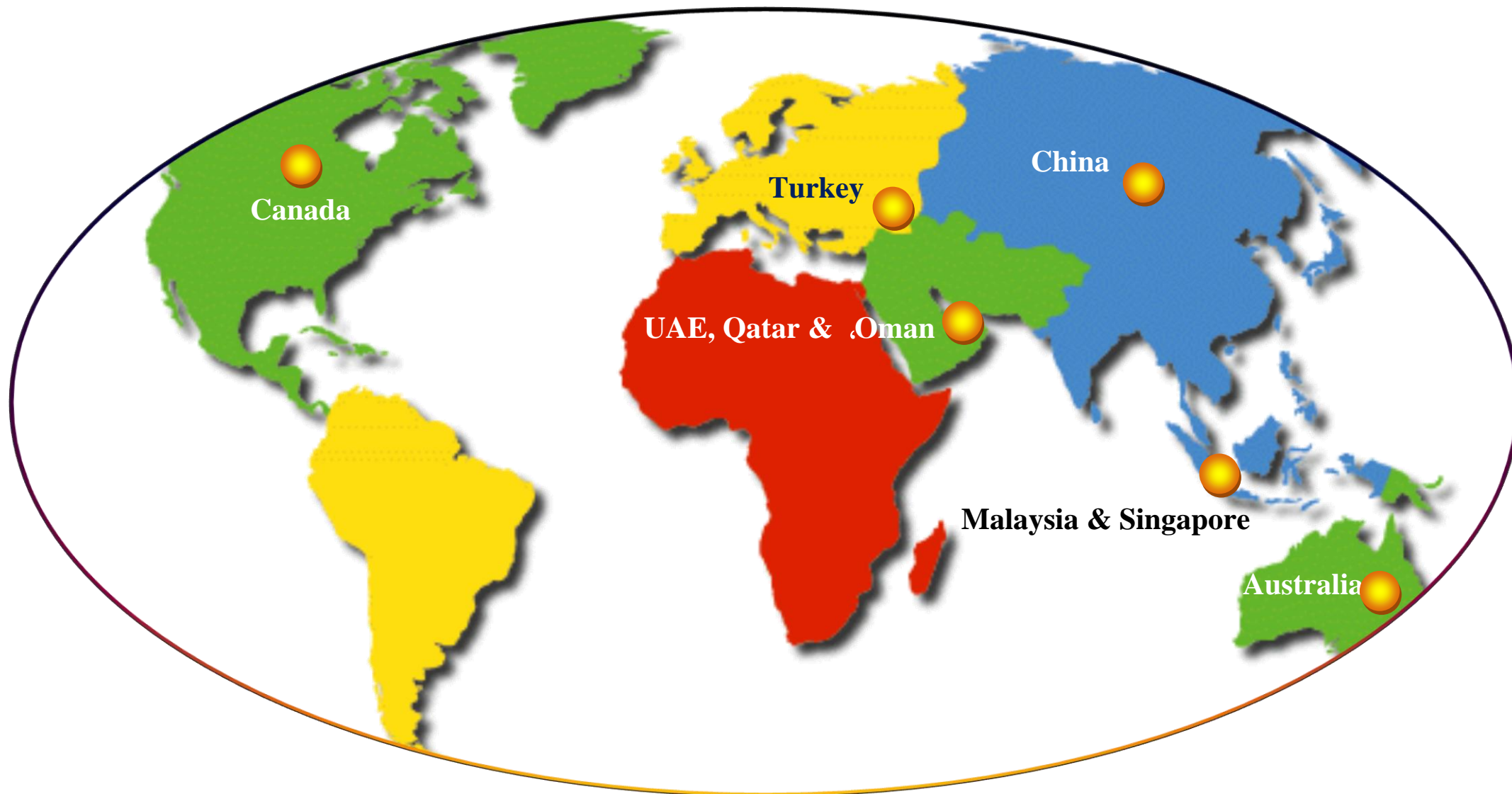


